WHY BUSINESS ECONOMICS?

Do you wonder why a brand-new car you purchased is worth less the moment you drive it off the seller's lot? Or why one firm markets its products more successfully than another firm? Are you intrigued by why some countries have been performing well even in times of crisis? Do you want to know how best to motivate your employees? Then you should consider studying Business Economics.

You will learn how firms shape our lives

Companies play a major part in society. They produce most of the goods and services we consume. Videogames, smartphones, fruits and vegetables, cars: everything you can imagine is produced by a firm, transported, sold and – preferably – recycled. In our Business Economics programme you will learn how businesses operate, by exploring the world of finance & accounting, marketing, management, human resources, and operations.

You want to help boost the economy

Society is constantly changing. Your future firm or organization needs to adapt to the ever-changing environment. To make this happen you will have to make decisions. Good ones. In Business Economics we will guide you from theory to practice to make better decisions. We develop your analytical skills to enable you to tackle complex problems head on.

You must be a jack of all trades

To make good decisions you need context. To keep an eye on the bigger picture you must have a thorough understanding of the economic, social, and legal environment. This knowledge is essential for firms to function, but also for government or not-forprofit organizations. Student, banker, president or spy: millions of people all over the world face trade-offs when they make decisions. Their choices add up to what makes the economy. No wonder the science of economics is so diverse and evolves so rapidly. To keep your head straight when faced with such complexity requires you to be a jack-of-all-trades. If you are such a versatile diamond in the rough, Vrije Universiteit Brussels is the right place for you.

From a business perspective Vrije Universiteit Brussels is more of a small or medium-sized enterprise than a conglomerate. Its scale brings obvious advantages. A personal approach for instance, so there is always someone to turn to when you have questions on your courses or your field of study. And what about our green main campus, where you will eat, drink, work out, and party? It is a campus that, just like the Business Economics programme, excels in diversity.

Accounting, mathematics and statistics? Make it count.

A business economist must be able to do the numbers. But that is only one reason why you need skills in accounting, math and statistics. During your career you will need analytical and empirical skills: to assess risks, to calculate the future value of assets, or to identify trends in time - or to conclude that there isn't a trend. You will learn to think and act as an economist. You will study what determines the trade balance of countries, learn how the money supply influences inflation, or how governments regulate monopolies, and why all this matters for business. You will study the importance of trust between buyers and sellers in second hand markets, or whether a company that is the only supplier in a market is eager to innovate. You will study economics starting from basic

You will study economics starting from basic principles. In year one you are introduced to

economic concepts, theories and models. In years two and three depth is added, with intermediate-level and advanced courses on macroeconomics, microeconomics, public finance, and international monetary economics.

People first, numbers second

Don't worry that you will be overwhelmed by theory. Other courses put the concepts to the test. Marketing, management, corporate finance, business law, and strategic brand management are just some of the applied courses that will help you manage a firm, or (why not?) set up your own company.

If you dream of a career as a manager do not forget to develop people skills. We will offer you plenty of space to meet up with students from different majors. And in the Business Economics programme we continuously emphasize that economics and business studies are part of

the social sciences and humanities. That is why the programme goes beyond the narrow confines of the major. This broad approach allows you to really grasp how people

International Business or Business & Technology?


While you will share the class room with your fellow students in your first two years, we will give

FOR YOUR INFORMATION

Introduction to microeconomics

Our needs continue to rise, and so does the demand for resources. But resources are scarce. In this course you discover how supply and demand interact in markets to determine prices and quantities. You learn to think like an economist by applying basic concepts. You study the demand side – the consumers – and the supply side – the producers. You explore which forms markets can take: monopolies, oligopolies, monopolistic competition and perfect competition. You study how government can influence market outcomes. In the second year this course is followed up by Intermediate Microeconomics.

Mathematics I

In this course you study the mathematical concepts and methods that are needed in your intermediate-level and advanced courses in business and economics. The approach is intuitive: mathematical proofs are kept at a minimum without losing rigor. All topics are illustrated through examples from business and economics. You will also acquire the mathematical knowledge to find your way in the scholarly literature on business and economics.

Marketing

This course introduces you to the basic concepts and activities of marketing. How do you segment a market, determine your target audience, and position your product? Which marketing mix (product, prize, promotion and place) do you choose? Starting from the definition of the marketing function in a company, you will frame marketing in the wider company strategy. All subjects that play a key role in modern marketing are tackled: how to analyze the internal and external market environment, to gather the information you need, to develop and implement a marketing strategy, to choose an appropriate marketing mix, and to understand the influence of the internet on marketing policy and practice. You study buyers' behavior of both individual consumers and companies, and investigate how to develop and implement a socially responsible marketing strategy.

Introduction to macroeconomics

This course covers the determination of the aggregate income of a country, long-run growth, employment and the unemployment rate, the interest rate, inflation, and the exchange rate. You then study the business cycle and how monetary and fiscal policy can (or cannot) smooth out fluctuations in output and employment. The course takes an international perspective throughout. In the second year this course is followed up by Intermediate Macroeconomics.

Academic writing

This course teaches the essential elements of written and spoken exposition, introduces you to the modes of critical thinking and writing practiced in the social sciences (in particular in the fields of business studies and economics), and provides you with criteria to evaluate your own written and oral work.



LIFE AFTER YOUR MASTER'S DEGREE

THE END IS ONLY THE BEGINNING

Imagine: your studies went perfectly and you just received your master's degree. You are beaming with pride, and rightly so. You are now armed with a degree to successfully enter the job market. But which way to go next? The opportunities are plentiful. Here as well, Vrije Universiteit Brussels is at your side.

Job opportunities

A degree in International Business is versatile. Graduates get jobs in a broad range of sectors like banking, insurance, audit or consulting, but also in public administration. They work in research departments or other staff functions in firms and organizations, and in operational functions as well. Some graduates become sales managers or human resources managers, others work in marketing. In short, the degree offers a broad range of opportunities.

Another degree?

You can of course decide to further specialize by doing another master's programme. After a short preparatory programme you can join our master in Communication Studies (with specializations in Journalism and Media in Europe, and New Media and Society in Europe). Or you can broaden your outlook by joining our Bachelor in Social Sciences.

Career guidance? One address: the VUB Career Center

Vrije Universiteit Brussel is known for educating critical, independent and open-minded people. Even then, taking the first steps in the job market can be hard. The VUB Career Center gives the small push you need. The Center helps you write a more effective CV, provides job interview training, and gives information on job opportunities. Don't hesitate to drop by, and do so while you are still a student: that way you are aware well in time what the job market has to offer.

Consider doing a PhD

After your master's degree you can also consider going for a PhD. Vrije Universiteit Brussel has three doctoral schools that support PhD students. The doctoral schools aim to stimulate and promote junior researchers by organizing workshops, seminars and master classes.

NEW IN TOWN? WELCOME!

A year is made up of two semesters

And each semester is 13 weeks. Each semester is followed by two weeks for rigorous exam preparation and other activities. In Dutch they call it, 'de blok'. This period is followed by three weeks of exams, both in January and June. In case you fail some exams there are resits in August and September. This may look like a tough schedule, but with decent planning and organisational skills you will manage. In addition, there is always tutoring - both Ghent University and the Vrije Universiteit Brussel have an excellent reputation when it comes to tutoring. And when things get busy, remember this: when everybody else is working hard in the beginning of February, you'll enjoy an extra week's holiday.

Tailored to your rhythm.

In the past, failing a course meant retaking the entire year's programme, but things have changed and are more flexible now. All you do now is retake the courses you didn't finish the next year, along with the new ones. This is what we call an individual study programme. You set up your own study programme in consultation with your study

counsellor, so for instance, you can combine studying and working.

What are academic competences?

Not jumping to conclusions. Drafting a research project with confidence so it meets scientific requirements. Being able to extract the essence from a hypothesis and communicate it clearly and concisely.

Thinking outside the box and finding new and unexpected connections. These are so-called academic competences. At the Vrije Universiteit Brussel you will learn to master them all.
